## **CONDITIONS OF ENTRY**

- 1) Artist Entry Form is to be received before the closing date
- 2) Artist Identification Label must be attached to the back of each artwork.
- 3) Artist Identification label must clearly state the name, section, title of work and sale price
- 4) All entries must be the signed, original work of the exhibitor
- 5) All entries must be in a finished state and ready for hanging with D hooks no lower than one quarter down from the top of the work. No wet paintings will be accepted on delivery. Works not ready for hanging will not be displayed.
- 6) All unsold artworks are the responsibility of the artist after 3 PM, 13th November
- 7) All entries must be for sale at a price no less than \$50.
- 8) All artworks must remain on display until 2 pm on 11th November.
- 9) Dimensions of works must be included on the entry form: height, width and weight (especially for ceramics and sculptures)
- 10) All works must be delivered in clearly labelled packaging and artists are responsible for insuring their works.
- 11) A commission of 10% of the sale price will be charged on all works sold.
- 12) Temora Shire Council reserves the right to: select the works to be shown, with such decisions being final; determine the way in which the works are hung; and publish images of prize-winning works.
- 13) Temora Shire Council and its delegates will exercise all reasonable care in the handling of artworks, but will not be responsible for any loss, theft or damage of works while in the custody of its delegates.
- 14) Artists are liable for any and all GST on sales and are personally responsible for any and all GST payments and compliance required by the ATO.
- 15) Prizes and voucher prizes are donated and are non-exchangeable, non-replaceable and non-redeemable for cash.
- 16) All Entries to sections 7-10 are Acquisitive and will become the property of the sponsor in exchange for the prize money specified for the section the artwork is entered.
- 17) Sections 1-15 and the \$1000 Open Prize are open to amateur artists only.
- 18) Section 16 is open to professional artists only
- 19) No artworks, including works that have been sold, are to be removed from the exhibition before the exhibition closes.
- 20) Artworks not removed by 31st December 2022 will be considered abandoned and will become the property of Temora Shire Council.
- 21) The Judge's decision is final.
